

## **Official Contest Rules – KNEX/KQUR – Pick Your Purse!**

1. NO PURCHASE NECESSARY TO PARTICIPATE OR WIN. VOID WHERE PROHIBITED, SOME RESTRICTIONS APPLY. Open to Laredo residents only.

2. SPONSORS: Radio United, LLC, including station KNEX "Hot 106.1" and KQUR "Digital 94.9" located at 216 W. Village Blvd. Suite 101, Laredo, Texas 78045 (the "Station"). The administrator of the Contest is Radio United, LLC. The Outlet Shoppes at Laredo is the promotional sponsor of this Contest.

3. DATES OF THE CONTEST: "Pick Your Purse" (The "Contest") begins on November 25th, 2024, and ends on December 20th, 2024. Specific times and locations will be announced on-air.
